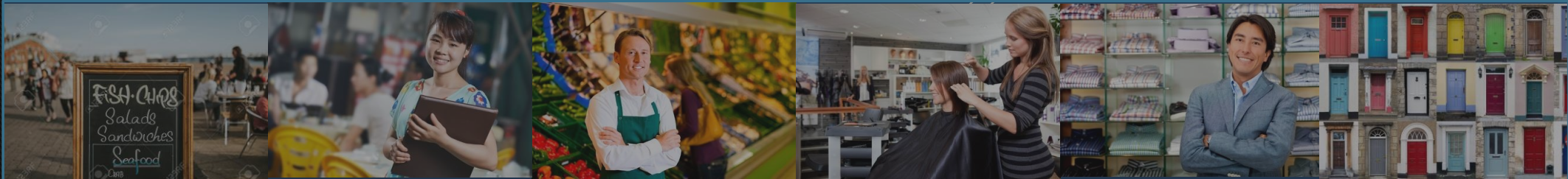
- Doulton Underwriting Agents Limited was incorporated in 1997 providing insurance intermediaries' facilities with which to place commercial insurance
